## Footway and layby repairs A23 Brighton Road, Hooley, Surrey

Connect Plus Services works on behalf of National Highways and Connect Plus to manage, operate and maintain the M25 and its linking roads, as well as the Dartford-Thurrock River Crossing.

We are writing to inform you about work due to start on the A23 Brighton Road, between the Netherne Drive and Dean Lane junctions. The work is scheduled to take place from **Monday 14 February** for approximately one month.

The Brighton Road northbound carriageway layby, opposite the Hooley Starbucks, will be closed from Monday 14 February for two weeks. The closure is needed while we break out the damaged concrete bay, cast new concrete and allow time for the materials to cure. A temporary traffic light system will be in place to ensure the work is delivered safely.

We will be resurfacing approximately 400 metres of the Brighton Road footway on the southbound side between the Star Lane and Church Lane junctions. This work is scheduled to take place overnight between 10pm and 5am from Monday 28 February for two and a half weeks, with a temporary two-way traffic light system and pedestrian diversion in place while work is underway. We've split the work into three separate phases to minimise disruption to

residents as greatly as possible. Temporary roadside signs will provide up to date information and we'll aim to maintain access throughout for properties adjacent to the works area; a member of the team will be on hand to assist should residents require overnight access.

Shorter sections of footway will also be repaired near the Hooley Starbucks and the 405 bus stop adjacent to Netherne Drive. A safe diversion around the work area will be in place for pedestrians.

If you need to travel while these works are taking place, we recommend that you plan ahead and allow more time for your journey. We have carefully planned and coordinated our works, but there may be some changes in the event of adverse weather, or other unplanned events. The work once completed will provide safer and improved pedestrian journeys.
